However, the obstacle here is the “Contextual Gap”. Language is not just a code to be cracked; it is a social performance. As the table indicates, AI may correct a sentence based on formal rules while missing the “soul” or the specific cultural nuance that makes the communication authentic.

2. Accessibility vs. The Digital Inequality

The “Availability” and “Cost” sections of the table point toward a socio-economic paradox. AI has the potential to democratize education by offering 24/7 access to high-quality language tutoring at a fraction of the cost of private human lessons. This could be a revolutionary “Potential” for developing nations [6]. Nevertheless, the “Obstacle” of the Digital Divide cannot be ignored. If the most effective AI tools require high-end hardware and stable internet, we risk creating a two-tier education system where only the wealthy can afford the “enhanced” learning experience.

3. Engagement vs. Academic Integrity

Finally, the “Motivation” category explores the psychological impact of AI. Through gamification and interactive streaks, AI keeps learners engaged in a way that traditional textbooks often fail to do. However, this creates a significant challenge regarding over-reliance [7]. When the tool becomes too efficient, the learner may shift from “learning with AI” to “letting AI do the work.” This threat to academic integrity is perhaps the most pressing obstacle for modern educational institutions, requiring a shift in how we assess student progress.

Discussion. The integration of Artificial Intelligence into foreign language pedagogy represents one of the most significant shifts in the history of education. As explored throughout this paper, the potential of AI to provide personalized, 24/7, and low-anxiety learning environments is undeniable. It offers a solution to the long-standing challenge of providing individualized attention to large groups of learners [8]. However, these opportunities are closely shadowed by obstacles such as the loss of socio-cultural depth, ethical concerns regarding academic integrity, and the persistent threat of the digital divide.

The findings of this study suggest that AI should not be viewed as a replacement for the human educator, but rather as a sophisticated complementary tool. While a machine can teach the “mechanics” of a language – its grammar, syntax, and vocabulary – it cannot yet transmit the empathy, cultural intuition, and emotional connection that define human communication. Therefore, the successful implementation of AI in the classroom depends on a “Hybrid Model,” where technology handles the repetitive, data-driven aspects of learning, while the human teacher focuses on mentorship, critical thinking, and cultural exchange.
